ENGINEER'S REPORT:**Jerry's Report:**

Jerry stated that he didn't have anything to bring up.

Martin's Report:

Sewage Pond = Martin stated that they are working on the pond and making progress. They will finish ahead of schedule.

ATTORNEY'S REPORT:

Ordinances regarding dancers = Attorney Landry stated this ordinance that he is presenting tonight is in reference to the pending litigation with Michael's. They have come up with a couple of ordinances. This will amend some ordinances, including ordinance #144. They had some discussion about repealing it. In section 2, section A, nude condition is described in accordance with state law. Section B was also added in accordance with state law. He will also put in the ordinance the state statute number in Section B. He is asking that they introduce this ordinance and it will be voted on at the next meeting. He feels this will save the city from any other litigation. They cannot say we are more restrictive than the state. Mr. Durand stated this is a constitutional as it will allow. He has presented this to their attorney's and this will be discussed in executive session.

Introductory Ordinance #09-350, amending Ordinance #144, regarding exotic dancing Moved by Councilman Rousseau and second by Councilman Romero to introduce Ordinance #09-350, which amends ordinance #144, which prohibits exotic, nude, semi-nude, and topless dancing on business premises required to hold an alcohol beverage permit, and located within the corporate limits of the City Broussard. Introduce Ordinance #09-351, amending Ordinance #05-289, registration of dancers

= The next ordinance #05-289 requires the dancers to register is also be suggested to revise. The new ordinance calls it a certificate of registration. The Supreme Court stated to dance is a form of expressing themselves. Requiring someone to get permission from the government is unconstitutional. They have worked with the attorneys just to change some things in the ordinance. This is important to know who works there for the police department. The ordinance will make it a little easier to work with for the dancers. Moved by Councilman Rousseau and second by Councilwoman Batiste to introduce Ordinance #09-351, which amends Ordinance #05-289, and provides for the registration of all employees and entertainers commonly known as “exotic dancers” who are employed in any establishment which sells alcohol. They received only one bid for \$21,132.00; therefore it was moved by Councilman Guilbeau and second by Councilman Higginbotham to award the bid to Casco Industries Incorporated for 12 sets of turnout gear at \$1,761 per set for a total of \$21,132.00. District I/Councilman Guilbeau:

Councilman Guilbeau stated the few items he has, he will get with Larry.

St. Etienne Road = Councilman Rousseau questioned when will St. Etienne Road be opened? Mayor Langlinais stated the lighting and intersection will be finished in 2 months.

Ambassador Caffery = Councilman Rousseau questioned if we have received anymore correspondence about opening up from Youngsville Highway to Verot School for Ambassador Caffery. Mayor Langlinais stated he has received only e-mail. Hopefully at end of July our section will be open.

District V/Councilman Higginbotham:

Lakeview Drive = Councilman Higginbotham stated that there is still one road in town that is gravel road, Lakeview Drive. The estimated cost to overlay the road is \$66,000 - \$70,000. He is asking the council to consider this project in the upcoming budget. Councilman Bonin stated we will probably have to beef up that road.

District IV/Councilwoman Batiste:

Washington Property = Councilwoman Batiste stated that she is working with the Washington's in reference to their house on Knight Street that burned. She is helping them out.

District VI/Councilman Romero:

Councilman Romero stated that he doesn't have anything to bring up.

At Large/Councilman Foco:

Councilman Foco stated that he doesn't have anything to report on.

Mayor Langlinais:

Sales Tax Revenues = Mayor Langlinais stated he received the sales tax report today. It has dropped a little, but he feels it will level out.

Citizen complaint regarding use of dumpster = Mayor Langlinais stated last month we had a citizen come to the meeting and complain about not being able to use the dumpster. His ex-wife telephoned us today and informed us that his tenants were dumping their garbage in her container and so was he and she is paying the bill. Mayor Langlinais stated that he instructed his people to deliver 4 cans to him and the tenants and they will be charged. The point is we do have recourse; he just wanted to pass it on.

TESI Meeting = Jerry and Mark set up a meeting with TESI. They spoke to an office manager about their plants. They expressed willingness to in reference to the sewer improvement

plan off of Heart D Farm Road.

Councilman Foco.....continued:

Animal Control Request = Councilman Foco stated that he would like to tell the Mayor he is behind him on the animal control thing. We need some answers to some questions. Councilman Foco questioned if we can ask them for an accounting of where our money goes? Gene stated absolutely. All the taxes are dedicated to something. He would like to know if they are going to charge per dog, he wants to know how much people use the library, the airport, the Cajundome. Mayor Langlinais stated they have answered some questions. They are dancing around whose responsibility it is. It is the parish's responsibility for the animal shelter and it is the sheriff's responsibility for picking up the animals. If we do it based on the calls thru the police department it is about \$800 a call. We will get some more information. Dee Stanley contacted Attorney Landry to see if we could be on board for this. Mayor Langlinais stated the City of Lafayette is saying it is their animal control shelter. He always thought it was a parish owned facility. Scott will not agree to this and Duson will not either. Councilman Foco stated if they handle this the way they handle Cypress Bayou we don't need to worry about this. Councilman Foco stated we always send money, but we don't get anything for the money. The council deferred this discussion for later.
